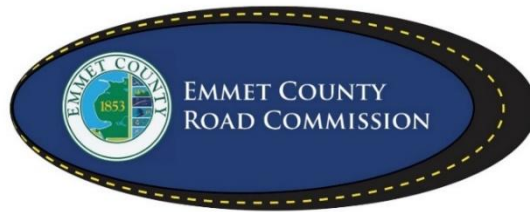

Cold Patch ECRC Bid No. 26-02

The Emmet County Road Commission will accept sealed bids for supplies pertaining to Cold Patch Materials. All Materials shall meet current ***MDOT Standards Specifications for Construction, 2020***.

These mixtures shall be capable of being loaded into trucks or patch trailers by either hand shovels or power loading equipment; shall be sufficiently workable immediately after preparation or over a period of at least 6 months in a stockpile for placing with shovels, rakes, or other hand tools; and shall readily compact by hand tamping, hand or power rolling, or under action of traffic at the temperature of mixing or at temperatures as low as 15 degrees Fahrenheit. The mix shall remain in place when used to patch wet or dry pavements and shall be stable under normal traffic conditions.

Safety Data Sheets and certification of all material shall be provided by the bidder at the time of order.

Bids shall be submitted on the enclosed ECRC Cold Patch Material Bid Sheet in a sealed envelope clearly identifying the bidder and marked "Cold Patch Material".

Bidders shall include a written statement of allowable discounts and terms of payment. Bid prices shall be valid for a period of one year from the date of award.

Sealed bids will be received until **9:00 a.m., Tuesday, February 10, 2026**, by the Emmet County Road Commission at their offices located at 2265 E. Hathaway Road, Harbor Springs, MI, at which time they will be publicly opened and read aloud.

The Emmet County Road Commission reserves the right to accept or reject any or all bids, to waive irregularities in the bid procedure and to award in the best interest of the Emmet County Road Commission.
