# **ENGINEER-MANAGER'S REPORT**: Gutowski offered the following:

- MCRCSIP Team Building Training today for supervisors at 11:00 a.m.
- Cross Village Township Meeting at 1:30 p.m. today regarding Lake Shore project changes
- Welcome to Travis Horrocks who was hired as Engineer-Technician
- MCRCSIP meeting next week in Detroit regarding investment losses

- Next Board meeting there will be bids for approval on Stanly Court, Artesian Lane, and Ellsworth Road.
- MDOT open house at Littlefield Township Hall today, 4:30-6:00 p.m., regarding the US 31 construction project.

Shank offered the following:

MDOT Detour Project funding has been confirmed and projects will be put out for bids.

**ENGINEER-TECHNICIAN'S REPORT**: Shank introduced Travis Horrocks; discussing his qualifications of being a licensed land surveyor with experience in project inspections and management, as well as cost containment. Horrock stated he has been working on expediting the MDOT detour route projects and gave details on Milton, Powers, North Conway, and West Conway Roads. The crossover between North Milton Road and US 31 will be widened to accommodate larger vehicles. Chip sealing will start Tuesday; it will take two weeks to seal coat and then fog coat. Horrocks assured the Board that based upon prior experience with Fahrner, they will have several broom trucks taking care of sweeping. The Board welcomed Horrocks.

**PERMIT/CAD TECHNICIAN'S REPORT**: Godzik stated he has been working with Charter on the lines that need to be removed on Kolinske Road; he is not issuing newly requested permits until they are taken are of. He also required a \$62,000 road bond for Riggsville Road due to the several issues in the past.

**EQUIPMENT SUPERINTENDENT'S REPORT:** Genson stated he has been talking with his peers about getting parts and helping each other out because the supply chain is difficult. In response to Commissioner Hoffman's questions regarding mowers, Genson discussed the two new tractors are here but the tractor in Flint is still not complete; several issues keep arising. Mower Max delivery has been moved to August from July.

**ROAD FOREMAN'S REPORT**: Zmikly stated the crew has been busy wedging in preparation for seal coating, graveling shoulders, and removing tree stumps on Wilderness Park Drive. Zulski asked him to check out a stump on State Road just north of Middle Village Road on the first curve, it is sticking up pretty high. Hoffman discussed there are some lilac bushes on the corner of State and Robinson Road that make it hard to see, but Zmikly stated they are out of the right-of-way.

**FINANCE DIRECTOR'S REPORT:** Kleeman distributed information and discussed the MTF to be received for April in June.

**COMMISSIONERS' REPORT:** Commission Williams would still like to see trees cut at the intersection of Powers Road and US 31.

#### PUBLIC COMMENT:

a. Gordon Kruskie, Readmond Township Trustee – they need additional millage to work on upcoming projects; this will need to be addressed at the upcoming election. Gutowski

stated he received a 5-year permit to get the culvert replaced on Gully Road and will be working on an estimate.

Commissioner Zulski recessed the meeting at 9:13 a.m.

Commissioner Zulski began the work meeting at 9:18 a.m.

2022 Budget changes and challenges were discussed. MTF reduction and increased gas/fuel prices have had significant impact on the budget. As more projects are planned and approved, the budget revisions will be finalized and presented for adoption in June.

2023 Equipment requests were discussed as well as how the savings account can accommodate the requests.

2022 and 2023 Projects were reviewed.

Commissioner Zulski adjourned the meeting at 10:34 a.m.
