- Working on estimates for townships with bids due January 16, 2024, for approximately \$1.6 million:
  - Resort Township Indian Garden Road and Stump Road
  - West Traverse Township Lower Shore Drive
  - Springvale Township Ellsworth Road and Roy Road
- Equipment auction resulted in just over \$7,300.
- McDougal Road Bridge guardrail was pulled up and the project turned out good for being completed so late in the season.

**PERMIT/CAD TECHNICIAN'S REPORT:** Godzik discussed a crew is still working on an underground project on Stanley Court; all other projects are completed for the year. He will be checking in the spring to be sure grass is growing on several projects.

Commissioner Williams stated the transition at McDougal Road Bridge turned out really well. He also let Godzik know there is still a roll of wire on the south end of Milton Road.
