## **ENGINEER-MANAGER'S REPORT**: Shank offered the following:

- New budget tool is being completed to tie the cash budget to the Act 51 budget.
- Road rating reports will be completed in the next week or so and sent to the townships so 2023 projects can begin to be planned. Hoffman requested the reports be emailed to the Board.
- Springvale Township and Lamkin Road gravel projects should begin by end of the month.

## **ENGINEER-TECHNICIAN'S REPORT**: Horrocks gave the following update:

- Levering Road is complete; some shoulder gravel may be added in the next few weeks.
- Powers Road from N. Conway Road to township line, N. Conway Road from US 31 to Powers Road, and W. Conway Road mill and fill is completed. Shoulders will probably be completed tomorrow. Paint on W. and N. Conway is planned for today.
- Cross Village Township Lake Shore Drive project is in process; some grade issues are being resolved. A catch basin location will be moved near Legs Inn.
- Powers Road curve relocation, Milton Road, and Wilderness Park Drive projects will begin in the middle of September.
- Robinson Road Bridge pile driving will begin Tuesday.
- Country Club Road is in progress and should be completed by end of next week.
- Crack Sealing crew is working very well.
- Bear Creek and Resort Township ultra-thins and overlays are all completed.

## PERMIT/CAD TECHNICIAN'S REPORT: None

**EQUIPMENT SUPERINTENDENT'S REPORT:** Genson reported the new MowerMax is outside and there was some discussion on training, operation, and design of the machine. The mechanics are just about finished with maintenance for the summer and winter preparation will begin in about three weeks.

**ROAD FOREMAN'S REPORT**: Gray stated they have been patching, ditching, blading, berm removal, and getting ready for winter. Zmikly stated they been doing a lot of patching, gravel shoulders on wedging projects, and finished stumping or flush cutting of stumps on Wilderness Park Drive.

**FINANCE DIRECTOR'S REPORT:** Kleeman distributed and discussed MTF for July to be received in September; the lowest amount this calendar year. She thanked Tori Thompson and the crew members who worked at the fair this year; Gray and Hoffman offered positive comments also.

**COMMISSIONERS' REPORT:** Commissioner Zulski thanked Thompson and the crew for their efforts at the fair.

Commissioner Hoffman offered positive comments about the fair booth; he suggested having a video available at the booth of snow plowing. He also discussed there is a tree down on our guardrail on Pickerel Lake Road; Gray commented he is aware of the situation as the tree is leaning on a line and involves Parish Communications.

Commissioner Williams discussed the need for brushing the ditches in Maple River Township where the paving was completed. Zmikly discussed mowing and priorities.

## **PUBLIC COMMENT:**

a. Bill Dohm, Little Traverse Township Supervisor – He is very impressed with the quality of the work Rieth-Riley is doing this year and offered his compliments. Shank mentioned we have a good employee overlooking the jobs.

Commissioner Zulski adjourned the meeting at 8:27 a.m.

## **RESOLUTION**

WHEREAS, the Michigan Department of Transportation ("MDOT") has presented a proposed contract for funds necessary to prepare a detour route to be used as MDOT performs construction along Highway US-31 from Blumke Road to Milton Road in 2023 and along Highway US-31 from Graham Road to Blumke Road in 2025; and

WHEREAS, the project involves hot mix asphalt base crushing and shaping and resurfacing work along North Milton Road from Valley Road to Highway US-31, including shoulder trenching, aggregate base, and gravel base work; double seal coat and fog coat work along Powers Road from High US-31 to Moore Road; curve relocation work along Powers Road from Moore Road to Luce Street; double seal coat and fog coat work along Powers Road from Luce Street to North Conway Road; hot mix asphalt milling and resurfacing work along North Conway Road from Highway US-31 to Powers Road and along West Conway Road from Highway US-31 to the railroad crossing; together with necessary related work, located within Emmet County; for Contract 22-5148, Job Number 216685CON;

NOW, THEREFORE, BE IT RESOLVED THAT, the Emmet County Board of Road Commissioners approve the signing of the contract with MDOT for the project, as stated above, and hereby authorize the Engineer-Manager, Robert B. Shank, and Finance Director, Lisa M. Kleeman, to sign Contract No. 22-5148;
