COMMISSIONERS' REPORT: Commissioner Zulski inquired on tree companies being available if required this winter. Gutowski is making a list and creating bid specifications with the plan to present this topic at the annual township meetings.

Zulski also asked Trailsend Bay Property Association representative Tom Miller if homeowners have considered the purchase or trade of available property and how the association would handle it. There was much conversation on property owners, required right-of-way, MDNR, Wawatam Township and Emmet County involvement in the process.

Zulski personally thanked the individuals who called Senator Wayne Schmidt regarding SB 396.

ROAD FOREMAN'S REPORT: Engineer-Manager Gutowski presented a plaque from MDOT to retiring Road Foreman Jim Kargol for his service. Ed Zmikly, north end foreman, stated cutting has begun on Wilderness Park Drive.

FINANCE DIRECTOR REPORT: Kleeman reported that there will be some health insurance benefit improvements with 44 North through the Health Reimbursement Account due to being under the cap. The Health Insurance In-Lieu of Payment for employees who opt out of agency provided health insurance coverage will be \$.36 lower per paycheck for 2019.

a. Tom Miller, Trailsend Bay Property Association, asked about a logging operation on Trails End Road.
