ENGINEER-MANAGER'S REPORT: Gutowski reported he has a meeting Monday with Jackie Pilette, Emmet Conservation District, on invasive species, treating our ROW, and possible funding. Next board meeting there will be several bids on Middle Road Bridge for materials, geotextile fabric, segmental block and guardrail.
