SUPERVISOR'S REPORT: Gutowski gave an update on the following:

- Stutsmanville Road turnaround is finishing up
- Rieth-Riley has a good start on the Stutsmanville BIA project from Pleasantview to State Road. The wedging has been completed as well as culvert replacement and tree removal.
- Tri-County Excavating has started on Country Club Road.
- Munger Road gravel contained rebar so gravel had to be excavated out and replaced.

PERMIT/CAD TECHNICIAN'S REPORT: Godzik gave an update on culvert installation status on Wilderness Park Drive from Cecil Bay Drive to Second Beach. Permits are beginning to increase.

- MDOT Meeting About \$100,000 of unspent funds for winter maintenance and materials will be transferred to our summer budget.

COMMISSIONERS' REPORT: Commissioner Zulski commented how quickly Johansen's Tree Services removed the large trees on Larks Lake Road. Commissioner Williams reiterated trees on any new projects need to be taken care of ahead of time to make the road last longer.

PUBLIC COMMENT:

- a. Gordon Kruskie, Readmond Township Trustee commented on the great amount and multiple dead trees along the roads that still need to be removed.
- b. Toni Drier, Emmet County Commissioner stated the road commission board appointment will be made May 20, 2021.

c. Thomas Miller, Trailsend Bay Property Association — offered comments on culverts that appear to have problems keeping gravel, another replaced culvert has problems with water flow and will need more ditching, and tree removal to be done by Great Lakes Energy. Gutowski stated grindings can be used in the culvert replacement areas and Godzik discussed the water problems with Zmikly which will be addressed in the future as well as the timeline for the tree removal which should occur soon.
