There is an MDOT Rural Elected Official Meeting, Tuesday, March 13, in Gaylord from 3-5:00 p.m., but he cannot attend as he will be in Lansing. He also has a Managers Meeting today in St. Ignace. He is on vacation part of Wednesday and the rest of the week and then will be attending a National Insurance Pool Board Meeting in San Diego next week. Gutowski received a request from the Union to meet after the next board meeting to begin negotiations. He also announced an award that was received for the Lower Shore Retention Wall as Elmer's received the award and paid for a duplicate award for the road commission. Gutowski also mentioned that MTF changes are currently being discussed by the Legislature that could provide for an additional \$400,000 for the road commission to receive yet this summer if it passes.
