ENGINEER-MANAGER REPORT: Shank discussed the following:

- 2025 Primary Road and Bridge Report is completed and posted to the website, along with all township road plans. A 2030 project will need to be added to the five-year primary road plan, but he is awaiting a road funding decision.
- Topics for annual township meetings will be wedging program, chipseal program, township road reports, and Ice Storm cleanup.
- Click Road Bridge repair will require the bridge deck to be pulled off and some new piles driven in order to get back to a full capacity load rating. John Henry Excavating has looked at this project and the estimate is between \$400,000-\$500,000 and will be planned for 2026 if funding is obtained.

ENGINEER-TECHNICIAN REPORT: Horrocks stated the following:

- Maxwell Road federal aid project, from Mitchell Road then south 8500 feet, is in progress with a plan to begin paving next week.
- Brutus Road project, from US31 to Cheboygan County line, is scheduled to begin September 22, 2025.
- BIA project for 2026 is Brutus Road, beginning at US 31 and heading west, will be planned as soon as projects are wrapped up.
- Federal Aid and Small Urban projects for 2026 will be submitted in October with an anticipated April letting.
- Equipment auction is scheduled for October 21, 2025.

PERMIT/CAD TECHNICIAN REPORT: Godzik discussed Final Grade's permit has expired with no changes made to the driveway; he inquired to the Board the next step. Zulski requested

sending a letter to determine zoning clarification and status before contacting the agency's attorney.

EQUIPMENT SUPERINTENDENT REPORT: Shaler stated the following:

- New hoist has been activated and turned out beautiful.
- Energreen tractor will be delivered without the blower and attached at a later time.
- Radios are waiting for state approval, could be another three weeks.
- Winter change over begins Monday.

ROAD FOREMEN REPORTS: Gray stated he has been busy handling call log maintenance requests and opening up roads. Zmikly stated wedging projects have been completed and discussed work planned for seasonal roads and maintenance.

FINANCE DIRECTOR REPORT: Kleeman stated the 2026 Original Budget has been created and reviewed with Shank. Significant unknown items at this time are the amount of MTF funding to be received and cost of health insurance. Next meeting is Friday, October 3, 2025.

COMMISSIONER REPORTS:

- c. Zulski Inquired on a plan for clearing seasonal roads. Shank stated the plan is to open the road and grind back to the tree line or five feet from the road edge. Overtime will be planned beginning this weekend. There is about 320 miles of road to be cleaned up yet.

PUBLIC COMMENT:

a. Dennis Keiser, Bear Creek Township Supervisor – Inquired how much pavement will need to be removed for the Click Road Bridge repair. Shank responded enough to allow a smooth transition.

Commissioner Zulski adjourned the meeting at 8:25 a.m.
