c. 8:30 a.m. Kira Davis - Program Director from the Conservation Resource Alliance presented on future projects. Ms. Davis handles finance and grant management and expressed appreciation for the partnership listed on our website. She distributed handouts on the history of funds brought into Emmet County showing since 2002 there have been \$2 million in projects with CRA's contribution at \$1.5 million. Ms. Davis discussed the U.S. Fish and Wildlife grant in the amount of \$125,000 for Van Creek and the critical need for a decision by May 15, 2018 or she may need to de-obligate funds and Emmet County could lose funds to another county. At the May 3 Board meeting, a biologist from CRA will be here to discuss the hydrological survey for the Van Creek crossing. She also discussed funds for Munger and Reed Road crossings over the Carp River, designs for construction and the need for a decision by May 10, 2018. Gutowski mentioned Mark Drier and Arden Bawkey were coming to the May 3 meeting to discuss Van Road along with NRCS, CRA, Grand Traverse Tribe, and Little Traverse Bay Band of Odawa Indians. He also stated Reed Road and Munger Road crossings over the Carp River are really old culverts. Reed Road culverts are not undersized but in very bad condition. Munger Road culverts are in terrible condition as well as undersized and could collapse before funding comes in. If they collapse, the road would need to be closed until funding is obtained. The funding would be used to design a timber structure to replace the current crossings. Ms. Davis estimated it would be about \$800,000 for all three replacements which also includes Gill Road. Van Creek and Reed Road bike trail crossings have been put in for funding application for replacement also with USFWS and NOAA. Gutowski stated the CRA has been involved in helping the road commission replace one or two of these crossings each year. Ms. Davis also stated the NRCS also tries to obtain funding through the tribe for these crossings. Zulski stated this has been a commitment benefiting the road commission and previous projects have exceeded expectations. People that use the crossings benefit and it also enhances the beauty of the river and he looks forward to a positive meeting on May 3. Ms. Davis also provided a Brutus Road completion sheet with costs and pictures. She mentioned the Woodland Road project is coming up along with others for a total of \$1.5 million. Gutowski discussed the process for the Woodland Road Bridge.

He discussed in detail the explanation for the increase in fund balance, amount spent on road building activities, long term debt, legacy costs, and the balance of liabilities verses assets.
