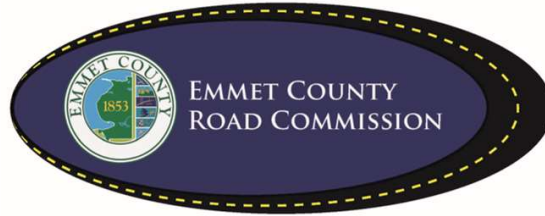

## **Dust Control ECRC Bid No. 24-03**

The Emmet County Road Commission will accept sealed bids for supplies pertaining to Dust Control material supply and application. All Work and Materials shall meet current ***MDOT Standards Specifications for Construction, 2020***. Successful bidder shall provide lab analysis of materials and Safety Data Sheets and Certifications that all materials meet State and/or Federal requirements for intended use. **NO FRACKING MATERIAL ALLOWED.**

Bidder shall provide proof of insurance including but not limited to public liability and property damage, workers compensation, unemployment and other coverage as might be required by law. The Bidder shall provide indemnifications for the Emmet County Road Commission for all claims arising as a result of operations in the performance of the above services.

Bids shall be submitted on the enclosed ECRC Dust Control/Brine Bid Sheet in a sealed envelope clearly identifying the bidder and marked "Dust Control/Brine".

Bid prices shall be valid for a period of one year from date of award.

Sealed bids will be received until **1:00 p.m., Monday, February 5, 2024**, by the Emmet County Road Commission at their offices located at 2265 E. Hathaway Road, Harbor Springs, MI, at which time they will be publicly opened and read aloud.

The Emmet County Road Commission reserves the right to accept or reject any or all bids, to waive irregularities in the bid procedure and to award in the best interest of the Emmet County Road Commission.
