ENGINEER-MANAGER'S REPORT: Gutowski offered the following:

- Bay Shore Pit meeting with attorney Joel Wurster and Manthei Construction at 9:00 a.m. on July 28.
- Preconstruction meeting for the bridge over Tannery Creek on Country Club Road will be Monday, August 1 at 10:00 a.m.

Shank offered the following construction updates:

• Iduna Lane, Rice Street, and Hendricks Street ultra-thins are done. Rolling Hills Lane is waiting for the mill to get here.

- Old 31 was paved last week, Camp Daggett Road is getting paved today, and Vantage
 View is waiting for the mill to get here.
- Levering Road will be crushed today; August 1 is tentative paving date.
- Lake Shore Drive Preconstruction meeting coming up.
- Wilderness Park Drive is still scheduled for September.

ENGINEER-TECHNICIAN'S REPORT: None.

PERMIT/CAD TECHNICIAN'S REPORT: Godzik gave an update on the Spierling driveway permit. Gutowski sent a cease-and-desist letter for construction on their permit that expired and about 2 days after letter was assumed received, the driveway was placed in. He is currently drafting another letter to be mailed to Spierling Trucking so we will wait and see how that goes.

ACD.net is the company working on Kolinski, Boyer, and Mitchell. They have been up on Kolinski and bored through conduit and will have to run the line through that yet. They were on Boyer Road and it looks like they didn't get too much done. He is trying to get with them to determine exact timeline.

Mitchell Road - last Tuesday a couple bucket trucks were staged but a couple hours later nothing was done. Godzik believes that will have to be bored as they are still in conflict with the City of Petoskey; still being worked at.

Robinson Road - Spectrum will be boring a line down on the north side of the road. Our construction is going the second week of August and they will be boring around our bridge project the first week of August. Bond was obtained because of what happened on Kolinski Road; there is a video log and he thinks this will be a good project.

Wilderness Park Drive - AT&T is currently there rerouting two phone lines, boring and they should be finished this week so our crew can finish stumping as soon as they are done.

EQUIPMENT SUPERINTENDENT'S REPORT: Genson stated they are working on winter maintenance and commented the MCRCSIP meeting last week was very good. Trailer from Enbridge is hooked up to our old truck and is usable. No update on the Mower Max; last he heard it was scheduled to be delivered in August.

ROAD FOREMAN'S REPORT: Gray stated they have been doing a lot of mowing, working on some projects, and another round of dust control is scheduled for the first week of August.

FINANCE DIRECTOR'S REPORT: Kleeman commented MTF has not been posted yet and the MCRCSIP meeting was excellent.

COMMISSIONERS' REPORT: Commissioner Zulski requested that Kleeman text the Board when MTF arrives with the amount. He also offered comments on the brush cutter being used on the north end and the difference it makes for visibility; please compliment the crew.

Commissioner Williams noticed edge of blacktop is all broken up by Bayview Country Club. Powers and Milton Road intersection during the bypass needs to be opened up. He also believes that after the MDOT project is complete, Powers Road will be used as a bypass and have more traffic than normal. He also mentioned the clearing of brush on the expressway and how it is an improvement of safety by clearing the right of ways back.

Commissioner Hoffman has the MCRCSIP Annual Meeting materials if anyone wants to see them, he talked with Representative O'Malley, and he mentioned the speaker at the meeting was very good. He also discussed letting the township supervisors know when we will be working on projects in their townships. Shank and Horrocks have begun sending out emails to the townships. While this information has been posted on Facebook, the townships would prefer email contact.

PUBLIC COMMENT:

a. Gordon Kruskie, Readmond Township – Inquired on the proposal for Lamkin Road construction in Readmond township; without the support of the other township, is it on hold? Zulski stated they are waiting for clarification if the other township does not want to do it, does the bid still hold, as well as the completion date. Shank will email the townships when he gets the information.

Commissioner Zulski adjourned the meeting at 8:50 a.m.
